PROHIBITED RIGHT TURNS ON RED

(a) All Times. Pursuant to the provisions of Section 313.03(c)(5) of the Codified Ordinances of the City of Rocky River, a turn against a steady red signal is hereby prohibited at the following intersections upon the posting and installation of the proper signs giving notice thereof as follows:

(b) School Days. Pursuant to the provisions of Section 313.03(c)(5) of the Codified Ordinances, it is hereby determined that the following intersections are used by a substantial number of school children and a hazard to such school children, and therefore, a Right Turn against a steady red signal is hereby prohibited between the hours of 7:00 a.m. to 9:00 a.m. and 2:00 p.m. to 4:00 p.m. on School Days at the following intersections upon the posting and installation of the proper signs giving notice thereof. "School Days" shall be deemed to mean days on which the City and/or Parochial school systems of the City of Rocky River shall be in regular session as provided by Ohio R.C. 3313.48; provided however, Council may, by resolution duly passed in accordance with its rules, suspend the operation and effect of this Section 3 as it may be amended from time to time, during the regularly scheduled summer school vacation months as determined by the Rocky River School Board.
